IT IS AGREED THAT THE APPLICANT WILL PAY ALL INVOICES AND OR BILLING STATEMENTS WITHIN THE TERMS AND CONDITIONS OF ALL INVOICES SUPPLIED BY R.H. MARLIN, INC. THE RATE IS ONE PERCENT (1%) PER MONTH, TWELVE PERCENT (12%) PER ANNUM, WHICHEVER IS GREATER. TOGETHER WITH COURT COST, ATTORNEY'S FEES OF NOT LESS THAN TWENTY-FIVE PERCENT (25%) OF THE UNPAID AMOUNT OF PRINCIPLE AND THE INTEREST AND COST OF COLLECTIONS WHICH "MARLIN" MAY INCURE IN THE ENFORCING OF THE TERMS AND CONDITIONS OF THIS AGREEMENT. ALL WITHOUT RELIEF FROM VALUATION AND APPRAISEMENT LAWS.
